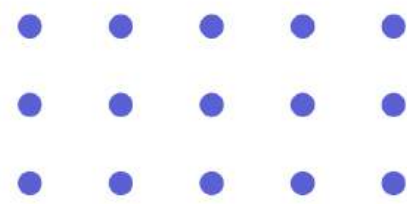

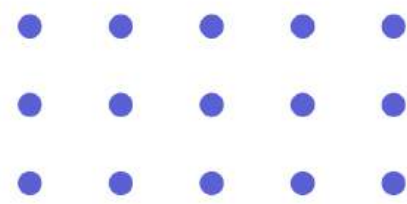

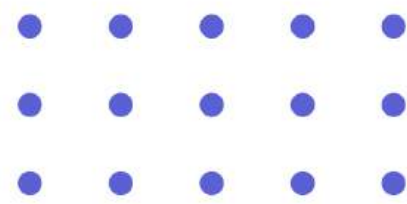
## VISION

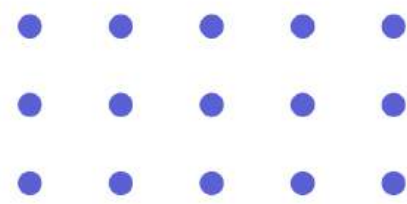
## OUR SERVICES

## **Sustainability Governance & ESG Disclosure**

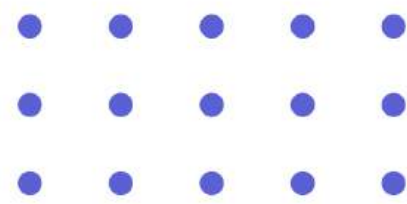
